
PS to tim

A tabular statement showing the provisions of the said Model Police Act and the decision of the MHA as arrived in these meetings is enclosed herewith. It is requested that a very Police Bill applicable for the Union Territories may kindly be drafted on the lines of the Model Police Act and as per the decisions indicated in the last column of the tabular statement. Hon'ble Home Minister has desired to introduce the Bill in the beginning of the ensuing session of Parliament. It is, therefore, requested that drafting of the Bill may kindly be taken up on priority basis.

2. As all the legislative work in respect of the Union Territories is handled by the UT Division in this Ministry, further action including preparation of required Cabinet note etc. will be taken by that Division. Shri B.A. Coutinho, Joint Secretary(UT) has been requested to follow up the matter from now onwards.
