Sir,

I am to refer to the above mentioned RTI application, the requisite information is as under:

1. As regard suo-motu cases, the Commission takes suo-motu cognizance in matters of Human Rights Violation reported through print/electronic media and seek action taken reports from the authorities concerned. Finally, taking into account the reports received from the authorities concerned and on the basis of analyzing the matter, issue further directions or close the case. As regard custodial deaths/rapes and encounter deaths, the Commission, on receipt of intimation from the authorities concerned seek action taken report from the authorities concerned. Finally, taking into account the reports received from the authorities concerned and on the basis of analyzing the matter, issue further directions or close the case. It is to clarify that proceedings of the Commission are deemed to be judicial proceedings, drawn in view of the facts and circumstances of the case, as per the wisdom of the Commission. The State-wise figures mentioned in the Annexure -2 of the Annual Report are taken from the Complaint Management Information System of the Commission and related to those cases, which were disposed off/concluded by the Commission.

2. As per practice, the Commission registers the cases state/UT- wise and every State/UT has been classified with a numeric code. As regards 'All India', it reflects those cases which have been registered on PAN India issues or on those complaints in which the name of State/UT is missing. These 'All India' cases are registered under code 90.

3. The desired list of disposed of cases pertaining to Custodial Deaths (Police Custody), Custodial Rapes (Police Custody), Death in Police Encounter, illegal Arrest and Unlawful Detention for the period from 01.01.2023 to 31.12.2023 is being sent to your Email. The information as sought by you in the prescribed proforma is not available on record of the Commission hence may please be regretted.

In this regard, it is pertinent to mention that the categories-wise details of action taken by the Commission as desired by you have been mentioned in the aforesaid list (under the 'Action' Category).
