O R D E R

By an Order dated 15.01.2020, I.A. No. 30915 of 2019 filed by the Applicant- Ms. Mideast integrated Steels Ltd. was allowed and it was permitted to sell the iron ore already mined and stacked by it before 01.01.2018 under the supervision of an authority to be appointed by the State Government subject to the sale process being deposited with the Special Purpose Vehicle (OMBADC).

The State Government was directed to appoint the supervisory authority within two weeks and the sale process preferably be completed within two months

thereafter.

I.A. No.46039 of 2020 has been filed for extension of time which was granted vide order dated 15.01.2020 by another six months. The Applicant has stated that the Supervisory Committee recommended that the sale process can take place only on 24.02.2020. Taking into account the reasons stated by the Applicant and the present extraordinary situation of the lockdown, we deem it fit to extend the time granted vide order dated 15.01.2020 by four months after the normalcy returns which would be from the lifting of the lockdown.

The I.A. is accordingly disposed of.
