1 I.A. No. 142745/2019- Application for intervention is allowed.

2. Learned Senior counsel appearing for the applicant(s) in I.A. No. 142758 of 2019 submits that all payments have been made and there is a delay of 459 days in making the payment of compensation in terms of this Court's judgment dated 02.08.2017. Applicant is seeking condonation of delay in

making the payment of compensation and is also seeking direction to the State Government to permit him to resume mining operation subject to receipt of all statutory clearances.

3. Learned counsel for the State submits that the State Government has no objection if the reliefs sought in the present application are granted by this Court.
