LETTER DATED 03.02.2021 OF LEARNED REGISTRAR GENERAL, HIGH COURT OF DELHI IN W.P.(CRL.) NO. 120 OF 2012

This is a letter received from the learned Registrar General of Delhi High Court seeking permission of this Court to nominate/post another suitable Officer as Special Judge in place of Mr. Bharat Parashar, Special Judge, in the matter which is pending

for about six years when the law contemplates the disposal of the such matters in two years which may be extended upto 4 times by periods of six months each.

We find that Mr. Bharat Parashar who has acted as a Special Judge (PC Act), (CBI)-07, Patiala House Court, New Delhi, needs to be replaced, as he has now completed more than 6 years in the same post after having been posted as Special Judge in the above mentioned court since 19.08.2014.

We accordingly request the Hon'ble Chief Justice, Delhi High Court to give us a panel of names of about five judges of a high caliber and absolute integrity to enable us to suggest an appropriate replacement for Mr. Bharat Parashar, Special Judge.
