UPON hearing the counsel the Court made the following
O R D E R

I.A. NO.12114/2020, I.A. NO.121119/2021 AND I.A. NO.153048/2021:-

1. In view of the averments made in the application seeking impleadment, the said application is allowed.
2. Cause title be amended accordingly.
3. Having heard learned counsel/learned Senior counsel appearing for the parties and taking into consideration the averments made in the said Interlocutory Applications, coupled with the fact that the learned Advocate General appearing for the State of Odisha has no objection to the same, the said applications are allowed in terms of prayer clauses at (a) and (b) in I.A. No.121119/2021 and prayer clause at (a) in I.A. No.153048/2021.

I.A. NO.112331/2020:-

1. Having heard learned counsel/learned Senior counsel appearing for the parties and taking into consideration the averments made in the said Interlocutory Application, the said application is allowed in terms of prayer clauses (a) to (c), subject to payment of compensation and balance amount of interest by the applicant.

1. Heard learned counsel/learned Senior counsel appearing for the parties and perused the material available on record.
2. Taking into consideration the averments made in the Interlocutory Application, the prayer at clause (b) is allowed.
3. As regards the prayer at clause (c), two weeks' time from today is granted to the CEC to file a report.

I.A. No.49058/2022:-

1. Heard learned counsel/learned Senior counsel appearing for the parties and perused the material available on record.
2. In view of the averments made in the application seeking impleadment, the said application is allowed.
3. Cause title be amended accordingly.
4. As regards the prayer at clause (b), the applicant would be at liberty to file a fresh application.

I.A. NO.51759/2021:-

1. Heard learned counsel/learned Senior counsel appearing for the parties and perused the material available on record.
2. Taking into consideration the averments made in the Interlocutory Application, we deem it appropriate to extend the time by six months from today for disposal of unsold stocks of iron ore of different grades and sizes which has been extracted, processed and stacked at the dispatch site within the lease hold area prior to 31.12.2017.
3. The application is allowed on the afore-stated terms.
